Shared a consulting firm visited this week to discuss the facility condition assessment for the BRIC and the BSC. He added that they will be writing a detailed report that will set up a long term budget planning for both buildings.

#### H) Special Presentation

- 1) Sports Clubs Presentation, Presented by Sport Clubs Program Staff
  - a) Nick and Bladimir gave a power presentation on Campus Recreations Sports clubs.

- b) Bladimir gave a brief history of the sports clubs that were created that still offered competition but were not as rigorous as intercollegiate athletics.
- c) Nick shared that during the 2014-15 year they went through a trial period with 9 club teams and 120 total students. Bladimir added the official launch year was in 2015-16 at that time there was 10 club teams and 317 students total.
- d) He added that now in the present year there are 7 active clubs involved in ultimate frisbee, Bronco Ascenders, roller hockey, volleyball, soccer, triathlon, and cycling. Competition is optional and teams that have traveled are the cycling team, volleyball, ultimate frisbee, and roller hockey.
- e) Bladimir discussed the criteria that needs to be met by the sports clubs one of the key criteria's is compete against other university club teams or in a competitive league.
- f) Nick reviewed the role of the staff that includes: Shelbi, Nick, Bladimir, Nataly, and the OSLCC and Bladimir discussed the registration process.
- g) Bladimir and Nick discussed the travel paperwork process and drivers.
- h) They also shared that the sports clubs have E-Board members they meet every 2 weeks in the school year. During these meetings they share updates and answer questions or concerns.
- i) Nick reviewed sport club benefits and future goals such as hosting events on campus, and increasing teams by adding basketball, badminton, marital arts, rugby, and tennis.
