The north end lobby elevator is out of order again. The issue is a recurring one concerning with the hydraulic fluid gasket that has ruptured and been replaced three times already. The elevator repair company is repairing it again and it should be back in operation next Tuesday. Manny is also requesting quotes to look at a more extensive repair to permanently fix the problem, which could be very extensive work.

Details: Recently contacted by Mike Biagi in Parking Services for student input on the bronco express contract

SUBJECT: SIRF (Student Involvement and Representation Fee)

Details: The California State University (CSU) Board of Trustees has adopted the Student Involvement and Representation Fee (SIRF), establishing a stable funding model for the California State Student Association (CSSA). Proposed by student leadership, the new funding model expands independence and builds capacity to engage students in advocacy and policy making. The funding model consists of a \$2 per-term fee assessed to each CSU student on a voluntary basis – allowing the choice to opt-out. The new fee takes effect in fall 2015. Founded in 1958, CSSA pushes legislation and internal CSU policies that are in the best interest of students. For example, CSSA successfully sponsored legislation to create fee installment plans for students, raise the Cal Grant eligibility age from 24 to 27, and add a student to the CSU Board of Trustees. There are now two student trustees serving on the board. CSSA has also engaged in issues benefiting students with disabilities, student veterans, and historically underserved student populations. The implications of this fee passing is that we would no longer be paying our current annual dues to CSSA out of our ASI Budget, thus freeing funds for other ventures. This is exciting news to students across the CSU.

SUBJECT: CHESS Conference

Details: The California Higher Education Student Summit, currently in its twentieth year, is an annual conference hosted by CSSA that empowers students to become change agents in advocating for an accessible, affordable, and quality system of public higher education for all Californians. During a two day conference held approximate to the state capitol, students participate in various training sessions on student leadership and governance, higher education and public policy, and conducting successful lobby visits in preparation for Advocacy Day at the Capitol. In addition, students are provided the unique opportunity to collaborate and network with state legislators and student leaders from all of CSU's 23 campuses. This year we will be bringing our lobby corp as well as an executive member, for which I have selected to be the Attorney General.

SUBJECT: Next Student Trustee

Details: The search for the next student trustee is here applications are due by Friday March 27th at 5pm. The California State University Board of Trustees includes two student members who serve staggered two-year terms. The first year of the term is spent learning about the position in a non-voting capacity, and the second year of the term is spent as the voting student trustee. The Board of Trustees is the policy-making body for the 23-campus CSU system. The student trustee has the unique opportunity to shape higher education policy for the largest public university system in the U.S. The Board of Trustees meets every other month in Long Beach. Each year, CSSA is responsible for conducting annual searches for the next CSU Student Trustee, who is ultimately appointed by the governor from a small pool of nominees provided by CSSA. Applicants should be passionate advocates for CSU students and have knowledge about CSU issues. Student trustees will have their CSU tuition waived and all pre-approved business travel will be covered by the CSU system. It's a great opportunity to advocate at the next level.

Details- Recap of the event is that it went well and there was a good amount of new questions asked, one being the reoccurring smoke free campus idea

SUBJECT: Fireside Chat with President Coley

Details- . The purpose of the video is to help highlight issues that are of particular importance to constituent groups and continue the weekly video messages to the campus community. President Coley prizes communication, and this is one method to keep a dialogue open. I have been invited to participate in this chat and to bring questions concerning the students, I will be reaching out drawing questions not asked at pizza with the presidents for this short 20min segment to make sure the student's concerns are being heard.

Details- I will be reaching out to student leaders, especially those who serve on semester conversion sub committees to come together and create a small task force to formulate questions and concerns that we should be bringing to our respective committees. As well as ways to get the message out there to the general student body.

SUBJECT: Smoke free Campus

Details- At the last CSSA Meeting this past weekend I connected with the President and Executive Vice President of Fullerton's ASI, they talked about conducting a joint meeting where we could discuss the topic and go through some of the pros and cons of converting over. I was prompted to look into the matter from students who requested that we do something about the current smoking rules and the litter on campus. I plan to go over strategies for polling the student body to see if this is something the majority of the campus wants to do, or if there is a compromise students want to propose.
