**ASI Executive Director's Report**

**1. SUBJECT: Campus Recreation – Scuba Trip Recap**

**DETAIL**

- The Scuba Program had 18 students participate. Sixteen students trained for their Open Water Scuba Certification, one trained for his Advanced Open Water Certification, and another trained for his Deep Diver Specialty Certification. All three courses consist of knowledge development via classroom sessions (assignments, quizzes, final exam), confined water sessions (practice in the pool), and open water sessions (diving skills in the ocean).
- Scuba gear was rented from Signature Scuba in Rancho Cucamonga and the boat “Conception” was serviced through Truth Aquatics. Students resided on a live-a-board boat for 48 hours while completing the open water portion of the course. These ocean dives took place in the Channel Islands on the southwest and northeast sides of Santa Cruz Island.
- Aquatic creature sightings include a Sunfish (mola mola), batfish, baby horn sharks, Garibaldi damselfish, seals, sea lions, whales, pods of dolphins, many wrasse, starfish, sea urchin, anemone, various crabs, octopus (night dive), and lots of kelp.
- After the certification requirements were met, many divers also explored the underwater opening of a cave on the northeast side of the island.
- Depending on the certification course, students paid \$245-\$275 each for the certification course including weekend trip.
