

**Bronco Recreation and Intramural Complex
Membership Eligibility, Pricing and Applicable Policies**

Eligibility

The Bronco Recreation and Intramural Complex (BRIC) is administered by Associated Students, Incorporated. The BRIC is not a public facility. An affiliation with California State Polytechnic University, Pomona (CPP) is required to be eligible for a membership.

Membership Category	Description/Qualifications	Quarter
STUDENT: ASSESSED	CPP student enrolled through regular session and incurs the full Bronco Student Center (BSC) Auxiliary Fee included in their quarterly tuition fees.	n/a
STUDENT: NON-ASSESSED	CPP student enrolled through regular session or special session (Open University and other College of Extended University programs) but not subject to the full Bronco Student Center (BSC) Auxiliary Fee.	\$140
STUDENT: CONTINUING	CPP student who is on an academic break (not to exceed 2 consecutive quarters), approved leave of absence, or is enrolled in the upcoming quarter.	\$140
FACULTY/STAFF	Employed by ASI, CPP and Cal Poly Pomona Foundation (CCPF) assigned a Bronco ID number. Includes retired campus Faculty/Staff.	\$140
ALUMNI	An individual who has completed a degree program at CPP.	\$140
SPONSORED	An individual sponsored by a current member from another eligible membership category, at the discretion of ASI. Sponsor is responsible for the actions of individuals in this membership category.	\$140
AFFILIATE	An individual who is affiliated with the academic mission of Cal Poly Pomona.	\$140

Membership Rates

Base rates shall be adjusted annually based on the Higher Education Price Index (HEPI). Management is authorized to provide promotional rates to achieve service and revenue goals upon the recommendation of the Director of Recreation with the approval of the Executive Director. While membership rates include most BRIC programs and services, certain fees may be charged when applicable.

Age

All enrolled CPP students are eligible for membership. Other eligible individuals under the age of 18 shall be considered for membership at the discretion of ASI.

Waiver

A current, signed waiver must be on file for all members and guests. At time of registration, individuals under the age of eighteen (18) are required to submit a BRIC waiver signed a parent or legal guardian.

Proof of Identification

BRIC staff reserve the right to request photo identification in the form of a Bronco Identification Card or a government issued photo identification card.

Medical Insurance

Members and guests participate in all activities and programs at their own risk and are highly encouraged to consult a physician and obtain adequate health/accident insurance prior to participating in any physical activity.

Attendants/Aides

If a registered member requires assistance from an attendant inside the building, the attendant is permitted to accompany the member into the BRIC and assist the member without incurring a usage fee. This policy does not apply to physical therapists or any person providing a specific service without written permission from the Director of Recreation. A current, signed waiver must be on file for the attendant/aide.

General

Members who refuse to comply with facility policies, guidelines or staff requests or allow unauthorized users access to the BRIC may have their privileges suspended or revoked.
