**ASI Executive Director's Report**

**1. SUBJECT: Associate Director of Financial Services Search**

**DETAIL:**

- Scheduled on-campus interview for 5 finalists were completed as of Thursday, 2/10.
- The committee will convene this week to compile their feedback.
- Recommendations will be presented thereafter.

**2. SUBJECT: Ongoing Audits**

**DETAIL:**

- We received the Internal Control Questionnaire and Document Request for the Policy Compliance Audit to be conducted by the Chancellor's Office. The submission deadline is March 4<sup>th</sup>. The start date of the fieldwork is March 14, 2016 and the audit will conclude on April 8, 2016.

**3. SUBJECT: Centaurus Construction Update**

**DETAIL:**

- The repurposing of Centaurus to the BEAT and Student Activities and Programs Office is progressing well and is still on target to be completed in March. There have been some additions to the scope of work that has impacted the project budget, mostly as a result of upgrades to building codes and the resulting compliance with Fire Marshall instructions. A budget update will be presented at a future Senate meeting.

**4. SUBJECT: Campus Recreation Updates**

**DETAIL:**

- **FACILITIES:** Temporary signage has been placed around the track to guide members on directional use of this facility. This practice supports the longevity of the flooring and helps to prevent collisions.
- **NEW PROGRAMS:** In anticipation of the upcoming spring break trip to the Eastern Sierras and because it is essential that outdoor recreation trips be as accessible and inclusive as possible, insulation (puffy jackets) and rain gear have been added to our equipment inventory.

- **CLASSES:** Classes offered through Campus Recreation are always free to BRIC members. Nine participants furthered their outdoor climbing skills by participating in How to Spot for Outdoor Bouldering and Whoopsies (topic: belay/rappel techniques in the event the belay/rappel device is dropped). The Bronco Peak community continues to grow welcoming 40 new participants who completed the Climbing Wall Orientation and Belay class.
- **WORKSHOPS:** Almost 100 participants have registered for workshops this quarter on topics including Slacklining, Lead Climbing and Anchor Building.
- **TRIPS:** Hiking, rock climbing, mountain biking, snowshoeing, alpine climbing, and a Spring Break trip to the Eastern Sierra are all available this quarter. To date, twenty-eight participants have registered for one or more of these exciting trips.
- **LEAGUES:** Last week, 137 teams started their Winter Intramural Sports league. 1,065 participants are playing volleyball, basketball, indoor soccer, and/or racquetball. The CPP Run and Walk Group has returned. A partnership between Campus Recreation and the Wellness Center, this steadily growing group meets on Wednesdays at 4:30 pm in front of the BRIC for 1-3 mile routes around campus.
- **CERTIFICATION COURSES:** ASI's first American Red Cross CPR Instructor certification course starts next Friday, February 19<sup>th</sup>. This course is scheduled over three consecutive Fridays from 1-5pm each day. The week of February 20<sup>th</sup> is the Title 22 (First Aid for Public Safety Personnel) certification course.
- **TOURNAMENTS/COMPETITIONS:** The Swim Meet on January 27<sup>th</sup> enlisted five swimmers who competed in the 100 meter butterfly, freestyle, backstroke, and breaststroke; the 200 meter freestyle and individual medley, and 50 m free. This tournament is the first of many intramural sports activities this year including an Inner-tube Water Polo league planned for spring. Upcoming tournaments this quarter are Quidditch (2/19) and March Madness Bracket Challenge (3/14).
- **STAFFING CHANGES/UPDATES:** Two new Adventures Attendants, Julian Andrews and Rhianna Orton, have joined the team.
- **EMERGING LEADERS (STUDENT STAFF TRAINING/DEVELOPMENT)** Eight student staff have gained new nationally and internationally recognized certifications. Dakota Robarge and Ben Kahn are now certified Wilderness First Responders. Clark Reinholtz and Eric Santos are now certified AMGA Single Pitch Instructors. Madison Anderson, Gregory Owyang, and Eric Santos have obtained their Wilderness First Aid certifications. Madison, Gregory, Kevin Ross Ng, and Colleen Fisher have obtained their AMGA Climbing Wall Instructor Certifications.
- Five Officials will be attending the SCIOA (Southern California Intramural Officials Association) Basketball Clinic at UC Irvine on February 20<sup>th</sup>. Intramural Sports Officials from Southern California universities participate in this clinic to strengthen their officiating skills and prepare for regional tournaments.

The students took it upon themselves to draft a rebuttal and have sent their comments to the general staff of PolyCentric as well as Benjamin Quillian, the acting VP and CFO for Administrative Affairs. Response to the PolyCentric Article: Q&A: California Air Resources Board and Cal Poly Pomona

Some of the information in this article requires further discussion and information so that members of the campus community, our alumni, and other supporters will see a more complete picture and what the impacts will be on the College of Agriculture if the California Air Resources Board (CARB) construction project and other developments occur at our educational farm, Spadra Farm at Cal Poly Pomona. The students in the College of Agriculture have been in close contact with CARB and it is very clear that there have been some inconsistencies in information given in the proposal for the development of their project. It should be noted that CARB has been excellent at communicating with the students, and has been very cooperative and forthcoming with information as requested by us.

**To preface the comments, the following should also be noted: The CARB was told by Cal Poly Pomona Administration that the Spadra Farm site was just vacant land that was not being used for anything. This issue is not only about the development of the 17-acre CARB facility, (plus another 5-10 acres of land required to build a solar field, which is not mentioned in the article) but rather about the plans for development of the entire Spadra Farm, which is the intent of the University. Furthermore, the majority of the Administration's decisions regarding this educational farmland was decided without any input from the College of Agriculture, the college that would be most impacted. At our request, the Administration held an informational meeting for the students in October,**

**clarifying their intent to develop our educational farm. Please see our comments on the PolyCentric article, “Q&A: California Air Resources Board and Cal Poly Pomona,” published January 21<sup>st</sup>, 2016.**

**Poly Centric Question:** “Will there be any costs to Cal Poly Pomona?”

**PolyCentric Response:** “The project will be funded by the State of California, at no cost to Cal Poly Pomona. It is estimated that the State of California will make an investment of more than \$360 million into the project.” (This response pertains only to the assumed 17 acres for the facility.)

**Comment:** The cost to Cal Poly Pomona will be significant, as this represents the loss of land that is used daily for instructional purposes in the College of Agriculture. Furthermore, crops grown here are sold at the Farm Store, Farmers’ Markets, and to the food services on campus. There is no adequate way to compensate for this land loss and the loss of revenue from the crops produced. Currently this revenue goes to directly supporting the educational farm and student educational opportunities. Despite this, it should be noted that no effort for compensation has been offered to the College of Agriculture for the loss of this resource. This is the equivalent of taking teaching and research laboratory space from the College of Science, for example, and giving it to another state agency with nothing in return.

**PolyCentric Question:** If Cal Poly Pomona is selected as the preferred site, where would the proposed ARB facility be located?

**PolyCentric Response:** “Based on ARB’s selection criteria and the needs of Cal Poly Pomona, the site being considered is a 17-acre parcel on the Spadra land, which is 150 acres located approximately one mile from the core of campus.”

**Comment:** We were initially told that the CARB project would be 17 acres in the corner of Spadra Farm. When Cal Poly Pomona presented their proposal to the California Air Resources Board, the site was in the center of the educational farm, and most of the remaining land surrounding it was designated for the “amenities” (restaurants, Starbucks, shopping, etc.) for the employees of the CARB project. After further consideration and student complaints, the University has now indicated that they will move the CARB site to the corner they originally told us was the chosen site, as long as that suits the CARB needs. However, their intent is to develop the rest of the 150 acres either way, as shown in numerous documents and associated planning maps.

**PolyCentric Question:** Does the Proposal to locate the CARB facility on Spadra has negative implications for the College of Agriculture?

**PolyCentric Response:** “If the ARB choses the Cal Poly Pomona site as the location for its new facility, the ARB facility will not impact the more than 500 acres of land currently used by the College of Agriculture located on the core campus and the additional 770 acres located less than 20 minutes away in Chino. Fifty-three acres located in Santa Paula will also remain available to the College of Agriculture.”

**Comment:** This response is immensely misleading. The College of Agriculture has access to land on the core campus. This land is already being used for other agricultural purposes, or is too steep and hilly to utilize for crop production. This is the very reason

we grow field and row crops at Spadra Farm. The campus land is used in the following manner:

- **Open Range grazing land (not suitable for cropping, no irrigation):** Used by the Animal Science Department for instruction, research and production. **90 acres**
- **Land at Agriscapes used for pumpkin production, seasonal small scale vegetable production, school gardens, agritourism:** **12 acres**
- **Agriscapes Vineyard:** **1.5 acres**
- **Production vineyard near the 10 freeway entrance:** **8.3 acres**
- **Vacant property near the production vineyard:** This property is being used to replace the avocado production block that is being removed due to the 10 Freeway off-ramp reconstruction and resulting removal of avocado production.
- **Miscellaneous crops:** **11 acres** near the 10 freeway (this will also be lost to the new California Highway Patrol building that is being built on campus).
- **Perennial Tree Crops:** **34.6 acres.** Numerous historic trees and germplasm exist in the citrus and specialty tree crop blocks used for the production of oranges and orange juice and numerous other specialty fruits. All portions are used for instruction.
- **Arabian Horse Center:** **48 acres.** **13 acres** of their pasture was lost last spring to make way for a new dormitory, with the promise that no other land would be taken.
- **Beef Unit:** Used for instruction and production by the Animal Science Department. **36 acres**
- **Swine Unit:** Used for instruction and production by the Animal Science Department. **10 acres**
- **Sheep Unit:** Used for instruction and production by the Animal Science Department **7 acres**
- **The remaining land is too steep and rocky to use for any type of production.**

In addition, the land at the Chino Prison has very limited use and is not a substitute for Spadra. We cannot use it for classes, as it takes 30 minutes without traffic to get to the facility. Our agreement with the Prison does not allow us to use specific practices, install or grow anything over a certain height, and it gives us limited access to the facility because of its secure nature. The same holds true for the property in Santa Paula. It is two hours away from campus, not available for classes, but is used very well as a production farm to support our farming operations on campus, as was the wish of the donor. In addition, we have entered into a partnership with the California Avocado Commission to conduct research and outreach at a portion of Pine Tree Ranch. Substituting either the Chino Prison or the Santa Paula Pine Tree Ranch property for Spadra Farm will not work in any fashion.

The negative impact extends so far beyond this university. California is the #1 Agriculture producing state, and the College of Agriculture of Cal Poly Pomona is unique to Southern California. The College is effectively helping to ensure the continuance of the agriculture industry by training many of its future participants.

**PolyCentric Response:** “Currently the College of Agriculture has access to the entire 150-acre Spadra land and will continue to have access for the remainder of the 2015-16 academic year. For the next five years, however, the college will be able to use 70 acres of Spadra. If the ARB decides not to locate its facility at Cal Poly Pomona, use of the remaining 80 acres will depend on the outcome of the university’s strategic planning process. If the ARB decides to locate on the 80-acre parcel and occupy 17 acres, the use of the remaining 63 acres will be determined during the strategic planning process.”

**Comment:** Currently we use 124 acres of Spadra for production and instruction. The remaining portion is inaccessible because it is either a marshy area or there are railroad

tracks passing diagonally through the farm. If the University leaves us only 70 acres, there will be further deductions from usable acreage due to the areas that are inaccessible. We will be left with far less than 70 acres. We actually need more than the current 124 acres of property on which to grow and to meet the needs of coursework, research, general production, and production for the food services on campus which is required to serve 20% locally grown produce.

**PolyCentric Response** “Although a portion of Spadra parcel may be used by the ARB, the College of Agriculture and the campus as a whole are expected to benefit from the ARB facility if Cal Poly Pomona is the chosen site. The ARB will bring high-tech, world-class research, training and learning opportunities for the university in a variety of fields, including agriculture, engineering, science, math, computer science, business, economics and political science.”

**Comment:** Previously, we also farmed the property where Innovation Village I sits, and we were also told that the tenants in that project would provide internships, research opportunities, etc. for students. To date, there have been exactly ZERO internships and other agricultural student benefits that have come from that project. While we do not discount the value of having the CARB facility on the campus, is it not likely to provide a significant number of student experiences for the College of Agriculture, if any. It will cause a great decline in the current student experiences (45% of Plant Science/Ag Science courses are taught at Spadra, and 100% of the students in Plant Science and Ag Science take coursework there). There will be no substitute for this educational farmland location.

**PolyCentric Question:** Is the proposed use of the 17-acre parcel on Spadra a sign of a diminished commitment to the College of Agriculture?

**PolyCentric Response:** “The university remains fully committed to the success of the College of Agriculture. A vital part of the strategic planning process will be devoted to charting a course for the future that will enhance the teaching and learning opportunities for the faculty and students in the College of Agriculture. The president recognizes and is planning to continue building the important legacy of the College of Agriculture and Cal Poly Pomona as a leading polytechnic university.”

**Comment:** We also find this comment very interesting, since the writer only comments on the 17 acre parcel (not including the extra land needed for the solar field to power the facility) and also does not mention that the entire Spadra Farm is planned for development at this time. While we understand that the University agreed to accommodate both the CARB and the California Highway Patrol in exchange for the Lanterman facility, none of this was discussed with the College of Agriculture. In fact, we would not have known about the plans for Spadra were it not for one of our fellow students seeing a group of people in suits viewing the property while he was out working in the field. When he asked what was going on, he was provided with no information. We were only told of the plans to develop Spadra Farm because we insisted that an informative meeting be held in October of this year. At that meeting, when asked if an Environmental Impact Report (EIR) for the development of Spadra Farm had been drafted, we were told point blank that it had not, which was a lie. An EIR draft had already been filed in August and was provided to us by the California Air Resources Board when we made a Public Records Request for all information related to development of Spadra Farm. In this draft EIR, it was indicated that there would be no significant impacts to agricultural resources if Spadra Farm were developed according to the maps included in the EIR. This is clearly not the case as we have indicated above.

**Obviously the University did not consider the College of Agriculture's interest in making these decisions. There is no compensation offered for these actions. Currently we have lost 13 acres of horse pasture (again without notice or discussion until we demanded information), 17-27 acres for CARB, 7-10 acres for the California Highway Patrol, and overall more than half of Spadra Farm, and most likely ALL of Spadra Farm, within 5 years. This will have devastating consequences for our education.**
