### General Duties:

Under the general supervision of the Children's Center Teacher, the Student Assistant provides classroom support for the Children's Center.

### Essential Duties:

- Greet parents and children
- Provides quality customer service and information
- Provides classroom assistance
  - Assists children, play or other planned activities to ensure their safety and comfort
  - Monitors children at all times. Accompanies children between activities.
  - Observes children's behavior and reports any concerns to supervisor
  - Suggests activities or approaches that may be appropriate for the children
- Maintains work or play area in a safe, neat and clean condition
- Removes items that may be a possible hazard to a child
- Follows program policies and procedures and any regulatory mandates
- Answer customer inquiries; take and relay messages
- Perform data entry, copying and filing
- Performs errands on campus
- Perform other related duties as assigned

### Qualifications:

- Certification in pediatric CPR/AED (Employment offer contingent on obtaining CPR/AED certification within 30 days of hire)
- Paid or volunteer experience working with children 5 years and younger desirable.
- Must enjoy children and be patient and flexible.
- No Kitchen or Front Desk experience needed.
- Ability to work effectively in a team environment
- Ability to perceive children's needs and develop positive relationships
- Ability to communicate sensitive information with tact and consideration
- Ability to adapt willingly to frequent changes in activity, priorities, and/or work schedules.
- Ability to follow written and verbal instructions
- Ability to anticipate and diffuse problems and disruptive situations
- Ability to satisfactorily complete a background check (including a criminal records check)

### Position Sensitivity:

Based on the duties and responsibilities of this position, this position has been designated to be a sensitive position.

### Background Check:

A background check (including a criminal records check) must be completed satisfactorily before any candidate can be offered a position with Associated Students, Inc., Cal Poly Pomona. Failure to satisfactorily complete the background check may affect the application status of applicants or continued employment of current ASI employees who apply for this position.

### Work Environment:

While performing the duties of this job, the employee is frequently required to sit, talk and hear; manual dexterity, eye-hand coordination, and verbal communication; use of office equipment: telephones, calculator, copier and fax. Must be able to walk, stand, bend and lift up to 45 pounds.

**Employment Eligibility:**

Employment with ASI is open to any Cal Poly Pomona student who is eligible to work and has the legal right to work in the United States. In addition, the employee must be currently enrolled for at least 6.0 units (undergraduate) and 4.0 units (graduate) at the end of the add-drop period, have a minimum 2.0 GPA and be in good standing with the University. Individuals enrolled only in Extended University are not eligible for hire. Exceptions to the unit load requirement are allowed during the summer quarter and for students who have applied for graduation for the current quarter.
