Open Forum (Information)

Pro Temp: Excited for this opportunity to have a university advisor from SELS. Most of the work that ASI Financial Services does correlates with the requirements from SELS for clubs and councils, so this will be a great way to reduce unnecessary barriers for students.

Additional Budget Request: Formula SAE Electric (Discussion)

President: What is your affiliation with the Club? A: We are the Treasurer and President of the Club.

President: Would you both be able to attend the Conference?

A: yes

Business: This project has been in works for a while, did you not have a specific line item in the budget for these purchases? Can you provide more clarification on that?

A: The year before last year, their club was inactive. Last year, they did not have a budget to manufacture anything. This year, they do have some finalized designs, so they are able to put together an accurate parts list.

Engineering: You are requesting nearly \$6,000. Are you only relying on ASI to fund your club, or do you have other sponsors?

A: Their current club budget is 10,000. They are relying on ASI to help most of the financial compensation for the club.

Pro-temp: Do you have a line-item for the conference? How much will it cost and how many students are going?

A: 15 students will be going to the conference, but the competition is in 2024, a year and a half away. So, the club would include the line-items in the future fiscal years. This year they are only requesting the budget to assemble the car.

Additional Budget Request: Finance Society (Discussion)

University Advisor: Is the airfare for New York for \$300?

A: Earlier this year, the price was \$280, so there is some variety depending on the season. But, they verified the cost in the attached documents.

Engineering: For the lodging and conference fee, is there a way for you to show where those numbers came from, or are you using the estimation from previous conferences for them?

A: They have the screenshots from the pricing from two days ago in the folder for reference.

Pro- Temp: Have you had the conference in the past or is this a first-time occurrence? A: First time since the pandemic.

University Advisor: Is there a reason why the conference wasn't it in your club budget earlier? A: UBSS denied the amount: We don't know why it was denied.

Additional Budget Request: SMIC Student Managed Investment Club (Discussion)

Pro-temp: Will this be the first time your club will be attending the conference?

A: Yes

University Advisor: How do you determine who gets to go to the conference? 4 people is a very selective number

A: They will likely use an essay type system to select the 4 individuals.
