ACTION ITEMS

1. 2019-2020 External Audit – Associated Students Inc., including Bronco Student Center

Using the Executive Summary in the board packet, Andy Maffia outlined the process, timeline, and outcome of the audit. Andy stated ASI received an unmodified opinion. he highest level of opinion available. He also stated there were no material weaknesses in ASI's internal controls. Andy and his team received full cooperation from ASI management and staff throughout the audit process.

A new standard, ASU 2018-08, was adopted by ASI during this fiscal year, related to revenue recognition for grants and contributions. A second standard was extended to next fiscal year due to Covid-19. That standard will be related to revenue recognition for exchange transactions, which will affect ASI due to student fees.

The committee also reviewed the entire financial statements packet. Andy gave a very brief overview of the Statement of Financial Position, Statement of Activities, Statement of Functional Expenses and Statement of Cash Flows. Andy also briefly discussed some of the difference in the Notes to the Financial Statements, compared to prior year.
