Discussion Item

Vice President Absences

SIC: Talked to Board members and fellow students about this. He has disappeared in this very important time. Asking staff to provide answers including President who is not here. Encouraging everyone to establish their concerns.

Protemp: Was not notified until the most recent week. There was minimal communication with him.

Business: There have been important conversations in R&P and BOD and he has not showed up to any of them. Many students outside of ASI have been confused about his absence. He did not even address his absence and many are confused about it.

ENV: Lack of communication within BOD, in general he has not been able to be reached at all. I could not attend a meeting because of a final and I usually reach out to him about that, but I could not reach him and had to reach LK.

Science: Could not reach him

Executive Director: Only excused absences when talking to the Vice Chair have been noted. He has not communicated with me at all. They are not excused if that is the case. The Board can take action.

Greek: Is there any point to removing him because this is the last BOD. He has not responded in the last few months with me. If he has financial or health concerns, we don't know and that has to be considered.

Treasurer: As far as Finance committee, VP stopped showing up and his absence has been unexcused. Can ASI Executive Director explain actions we can take against him.

ASIED: With the approval of the President and 2/3 vote, the Vice President's knowledge, and the ability for the VP to respond in an open session.

IHC: It is unfortunate and I have been wondering where he is. It is pointless to take any action. What can we actually do? As a person, I think something is wrong because he would not just disappear

TREASURER: I know we're already at the end of the year but keep in mind the Vice President does receive a scholarship which is paid by the student dollar. If we proceeded with the process of removal how would that affect the scholarship? What would happen to it?

ASI ADVISOR: If he is removed from office he will not receive the last drop of the scholarship.

SIC: How quickly can we start the process? If we have not communicated reasons for not submitting our transition folders we were told we wouldn't get the last part of our scholarship. So would we even need to continue with that if he's not submitted it.

ASI ADVISOR: We don't know if he's submitted it but I have to talk to legal about removing him from office. If we have a board of directors available to meet. Ginny could we convene the interim management group (aka board)

ASI BOD ADVISOR: We would need legal council perspective on it since this is the last regularly scheduled bod. Typically a special meeting can be set up within 24 hour notice but with due process there's not a specific time allotment. The interim management clause it what we would have to enact.

BUSINESS: Earlier this week she was talking to business students and they said the vp and president went to Germany on a trip that was for asi business. Was this trip made known to the board? If it was for asi business wouldn't the board have to vote on where the funds would be allocated for. People wanted to know what the trip was for.

ASI ADVISOR: The trip was not for business it was university funded and for leadership. Sanctioned and official.

CEIS: The president would need to approve the oversight of removal?

ASI ADVISOR: A two third vote is needed if the president hasn't recommended it.

SIC: So we need to speak with our legal team before taking any steps? If we can't meet next week we have to figure out if we meet quorum without the graduating senators.

ASI ADVISOR: We'll make a determination after speaking to legal

TREASURER: Do we have until may 31 to host a special meeting

ASI ADVISOR: Schedule a regular meeting next Thursday and if that doesn't work we can call an interim management meeting before graduation

SIC: In favor of holding a meeting next Thursday? What does everyone think do we need a vote or just have peoples opinions

ASI BOD ADVISOR: Chair can just schedule this meeting. If you want to compel the chair to do it then we would need a vote

CHAIR: Everyone seems to be in the same consensus about repercussions for the vice presidents leave of absence.

SCIENCE: Will the time of BOD be different since it's finals week?

ASI BOD ADVISOR: Cancel vote and continue discussion on active motion

BUSINESS: Will this meeting happen before the scholarship will be dispersed?

ASI ADVISOR: The processing of the scholarship as been started however we can pause it until the action has been concluded

IHC: I managed to get ahold of the vp who said the reason he has not reached out to pro staff is that they are mandated reporters and there would've been a much greater act of measures being taken had he explained his absence. He expresses safety concerns based on what's been happening on campus recently.

ASI BOD ADVISOR: There is still an active motion on the floor. The vote has been canceled to finish the discussion on the motion.

SIC: While there are valid reasons for why he's not here he hasn't had an explanation this entire time he's been gone. It's not just about this past week I hope you vote yes for the meeting for next week

CEIS: Echo the points made by SIC, if the vp was aware of his ability to communicate its on him for not doing so. He could've resigned

SCIENCE: He has been part of ASI for multiple years. Puts the claim of potential danger to question and as a board we should've been notified.

AG: We've been on zoom for most of these meetings so even if safety was a concern, we've been on zoom

ENV: SIC mentioned how we should analyze his entire term but we're talking about the entire year but it seems like before these couple of weeks it seemed like it was okay.

IHC: If we are talking about the entire year this is his first time of behaving in terms of taking disciplinary action, he has done good work this entire year excluding these past few weeks. What were the previous instances where he fell flat?

SIC: His absence from other committee meetings establish his failure as vice president. The meeting would be about reasons for calling for his removal.

TREASURER: This isn't about bod attendance solely, it's about his attendance at all committees.

SCIENCE: We have very well been talked to in case we take committee meetings solely from zoom and are highly encouraged to go in person and the vp has never shown up in person to the committee I'm in. We were incredibly surprised to see the turnout on ASI and people from MESA came in and made multiple attempts to reach out which were being sent to the vp. None of the information had reached the board from vp
