This form is to be completed each time a Sport Club member or coach plans on driving his/her personal vehicle(s) to transport themselves and/or other members of the Sport Club to and from an official Sport Club event/activity. **All approved drivers must submit a copy of their Driver's License, Proof of Auto Insurance, and be enrolled in the California DMV Driver Pull Program.**

Before using a personal vehicle for sports club travel, I hereby certify that I understand and agree that the ASI Campus Recreation Sports Clubs are not responsible for Sports Club travel and do not provide auto insurance for the vehicle, the driver(s), or occupants and are not liable for personal injury or property damage, including damage to the vehicle incurred during sport club travel. The Sports Clubs office will have to approve each driver upon receiving all the necessary documents and forms. As owner/driver of the vehicle, I understand that I may be exposing myself to personal liability in the event of an accident. Additionally, California state law requires the owner possess the following liability insurance:

1. **\$15,000 per personal injury to or death of, one person**
2. **\$30,000 for personal injury to two or more persons in one accident**
3. **\$5,000 for property damage**

With the forgoing understanding, I voluntarily undertake the use of the above vehicle for travel of the Sports Club program.

I verify I have not received more than two moving violations in the past 12 months and have no violations for driving while under the influence or for reckless driving.

I verify the stated vehicle is adequate for sports club travel, is equipped with one seat belt per passenger, and is in safe operating condition.

Should any of the information change during the year, I agree to update the information by submitting a new form to the Sport Club office within two weeks of the change.

I release and fully discharge the Associated Students, Inc., Sport Clubs, and Cal Poly Pomona from all liability in connection with the use of my vehicle for Sport Club travel for or on account of any injury to or illness of my person or death, or that of any passenger in my vehicle, or for or on account of any loss or damage to any personal property or personal effects owed by me or any passenger.
