# **Open Forum**

### **Discussion Items**

**BSC Furniture Project** 

Vp: what is the plan for older furniture

A: we developed an inventory app that we partnered with cal poly on and inventoried all the furniture in this building. It will be recycled, repurpose, or sold

VP: our office is not included in the project so looking into using the old furniture in our space Ag: what did you hear the most from students?

A: the power. We hear that a lot from everyone we work with, so this wasn't surprising. Treasurer: was there one response from students that was a driving force in terms of design that you didn't think of other than power

A: we asked students if it's the location or comfort of the furniture that made them want to work there and they said the comfort. Also make it cool not hospital feeling.

Treasurer: for chairs that will be everywhere how will we maintain the cleanliness of these spaces since there's so many books and crannies.

A: the seats will be pulled right out and the whole shell will be laminated. So it's entirely bleach cleanable. Seat cushions are velcroed down.

Env: issue with maintenance of electrical fixtures, is there a plan to maintain them? A: everything is warranted through us but the future proofing part of this is that over time we can pop out the port instead of replacing the device entirely.

Vp: how many students will it seat approximately?

A: no count. The only place were reduced seating is center court, all other places have been increased.

# **Council Elections Timeline Update**

Should we move elections up to the spring cycle for clubs that failed to apply by fall. My suggestion is that in the next 2-3 years we move it up so that councils can explain the budget to the new councils.

Env: would the elections happen at the end of fall? And serve their term for spring and fall? Would that mean those graduating wouldn't be able to serve on councils?

A: yes

Pro temp; I like the idea because it'll make the transition process easier. For those graduating it makes more sense to focus on that.

Ag: most of my council are seniors and it's really hard to get people to join council so it'll be hard finding people. Is it possible to do it later instead of doing it during fall.

A: the budget cycle starts in March so the whole reason for moving them forward is so that they can work with the current clubs

Treasurer: this would be granted for bettering the council process

Science: great idea but would be hard to get people on board because mute biggest reason for people becoming part of the council is for resume

Pres: with this timeline it could be spring of your 3<sup>rd</sup> fall of your 4<sup>th</sup>

Sic: if you're having winter be the period when they're shifting would you update the training period.

A: the training period is happening right now so there is plenty of time

Ag: would this be all councils or everyone in general

A: I'd like it to be everyone, but I know there are more logistics to consider

Treasurer: councils would be the test bed with the rollout be 2-3 years for the rest of campus A: yes, that sounds right

Treasurer: this pilot program would not be with the long-term goal of changing all of campus?

Env: would sg get affected?

A: no.

Vp: what problem are we fixing?

A: The change in councils when graduation happens is very inconvenient in terms of passing down information.

Vp: would not like this because of the ASI elections. How can we address the problems in another way.

A: if this is a multiyear roll out, we could also move it to January to March as well Pres: don't be immediately dismissive of the idea, initially liked the idea, take it to your councils.

Science: good idea just focusses on getting people interested earlier. Maybe offer incentives A: trying to get more involvement form seniors and undergrads

### CSU Systemwide Solidarity Movement

Pres: multiple students in CSSA feel a disconnect between CSU student leadership and our voice. Everyone was in support of the idea but if there is no strategic plan, since it would have to happen in spring, is that we need a plan. If we did this wrong and did a solidarity movement with no plan we could use our seat at the table and ability to provide input Env: what are the main issues?

Pres: cssa's policy agenda is that the cost of attendance. There's murmurs of tuition increase. CSSA president said that happened a year ago get over it. The cost of attendance was a thing. Env: is there a number or percentage? CFA wanted a 5% increase

Pres: still in an exploratory phase so there's so specific number since there's a lot that goes into the cost of attendance. Putting an actual metric is going to come later. How do you feel about this and is there a need to address this

Treasurer: how would we operationalize this,

Pres: it would be months of marketing and advocating about it. Getting a day plan and on the calendar for every student to do. There's consistent engagement issues on this. The whole reason is to show the power of the message so if we don't get people to come out it's futile. Treasurer: it might be a negative prospect for a lot of our students to spend the time and

resources to do this when we don't have much engagement at the moment. Might not provide support and drive a wedge between the student body and us.

Pres: good point not trying to be an advocate. We have to determine in the next month if we want to do it.

Pro temp: do we have talks planned with CSSA who are spearheading this?

Vp: a task force committee will be created, we won't be sitting on it

Env: what is the scale of it?

Vp: more of a walkout in support of this on one day. Not in favor of it. We are working on our relationships on this campus, and it would not be good for them.

Ag: will be difficult with no set goal, our student will not participate, are we even allowed to use asi resources to do this, would it affect our relationship with the president, we could show support in other ways

Pres: we can use asi resources for this because it's political advocacy

Motion Pres second mcc voice vote

### Council Unity Cup

We need funding for the event. Please ask your councils for the funding and make up your teams of 12 with 4 backups. 8 women 8 men.

Science: can we put our 500 to this event?

James: the money would be an option for the group

Treasurer: because this is a new program the npa can request 600\$

Liz: so, can request funds from npa to augment their funds. There's a clause that says sg can request funds through the finance committee for augmentations. Additional funds from what you were given for something new that shows up.

Vp: beat will prepare a rough budget so we can go off that to ask for a certain amount. We don't want to ask everyone to put their 500\$ in, we want the councils to have that. But there are councils that don't use some of their money so if you're able to do it then that would be great.

Env: why don't we use the graduating colors?

Vp: we can do that.

Treasurer: this could open us up to a liability by saying the gender requirements per team Krista: we have clean intramural guidelines to use that ensures our integrity

#### A2I Funds Adobe MAX Conference Attendance for 7 ASI Staff

Aspire to Inspire (better known as A2I) is ASI's application process for part-time and full-time staff to request funding to participate in professional development opportunities. Today, Yesi Dorado, ASI's Junior Designer Supervisor, will share about a recent opportunity that some of ASI's Marketing Team participated in.

Through the ASI A2I (Aspire to Inspire) professional development program, a team of seven staff from the ASI Marketing department, including junior and senior designers, a photographer, and the design manager, had the opportunity to attend Adobe MAX in Miami, Florida. Adobe MAX is a three-day conference designed for creatives who frequently use Adobe products. Each day began with a keynote discussion covering topics like current trends in graphic design and inspiring stories of resilience. On the last day, Max SNEAKS previewed upcoming Adobe projects. The "Creative Park" provided photo opportunities, networking, and hands-on exploration of Adobe tools. When they weren't exploring in the park, they attended a variety of sessions ranging from topics such as designing a fictional soda brand, tips on personal branding, and how to use generative AI as a tool, just to name a few. A major highlight was the chance to earn Adobe certifications at no cost. From the group, four staff earned certifications, with one member achieving five. Those who passed earned a certificate and badge, which can be added to LinkedIn profiles and resumes. For many of the staff, this was their first Adobe MAX and first solo travel experience. They returned with new skills, deeper insights into Adobe's creative universe, and, best of all, stronger connections with each other after sharing this unforgettable experience.
