## Discussion Items

### A. Candidate Attendance at Election Events

Molly: are they on the board to pick people or are they running  
A: they only said that it was mandatory, no clarification on whether or not they were on the deciding party  
Molly: if they were on the board, it would only be one position they're missing so they could continue to vote in their elections and missing that meeting is a reasonable sacrifice to make for the ASI Elections.  
Eric: seeing as it's something on behalf of their club that they volunteered to do, they would have more responsibility to their candidacy in the ASI Elections and could possibly have a proxy attend the council elections on their behalf.  
Jacob: The council elections is an extra curricular that the candidate chose to be a part of and even though their attendance is mandatory it is extra curricular, not a class or personal emergency. They chose to do it so they should be required to attend the ASI Elections event over the council one. Move it into an Action Item next meeting

### B. Candidate Campaign Materials

Eric: I cannot recall an exact portion in the code that says it is a violation, the flier seems to be more negative and a personal attack. I'm inclined to say it's almost inappropriate in a way. Creates an us vs them mentality in the elections. The flier doesn't represent their opponent as their views, it's more deconstructive. The whole picture isn't present.  
Molly: in agreement, there is no rule against this type of media in the campaign, alright in the legal sense regarding the code.  
Jacob: I don't feel that the marketing is violating any of the rules. Some instances of potentially inflammatory statements. "Stand with me against hate", potential ethical issues, "Campaign distribution" with false or misuse materials, seeing that this individual and mentioned it, siting it directly. This candidate sited it so she should site it correctly. No discourse if they prove their writing it accurately. Let them know to change their wording and change it accurately and noninflammatory.  
Anita: is it true all posting material needs to have approval from BLC?  
La'Keisha: yes

Eric: no concerns on the actual campaigning guidelines. Yes it's divisive wording should be kept truthful and factual. Inclined with approving this.

Molly: this should be all right with the wording change. Run it by the other candidate to make sure that everything is correct since it was run in the poly post.

Jacob: I don't feel the candidate has to do that, as long as the other candidate sees it as a misrepresentation they can file a violation form. The current individuals duty to market this accurately and they are running against each other. Counter intuitive to say I'm representing you in this light. Accurately do this. Keep inflammatory language to a minimum and not hateful in nature and accurately site what the opponent said.
